HOW TO BOOK

GETTING STARTED

Before undertaking any LGV or PCV driver training, you must first obtain provisional driving licence entitlement in your chosen category. If your current licence is for cars only, you will also need to have a medical.

THE NEXT STAGE

You must successfully pass the DSA theory test before you can take a practical driving test. We recommend that you attend our theory practice session before attempting the actual test since failure at this stage may delay the start of your practical training. For those candidates who wish to train over longer periods – pay as you go – then the Theory Test can be taken whenever convenient.

Please be aware that before being able to drive for a living, drivers who passed who passed their car test after 1996 and had not passed a Large Goods Vehicle Test by 10th September 2009 will be required to complete a two part Certificate of Professional Competence examination. Those drivers who fall outside the above categories will be able to drive for a living but must undertake 35 hours of classroom based periodic Certificate of Competence Training before September, 2014 for them to be able to continue to do so after this date.
